Southland Times 25 Nov 1863 Resident Magistrate's Court – Saturday, 21st November before M. Price, Esq., R.M.

Alleged robbery. Thomas Thorpe, alias _orkey, was charged with stealing a bag containing £40 from Richard Bulliman. It appeared by the evidence of the prosecutor, a butcher and general storekeeper in the ownership of Lauder, at the Elbow, that on the _th instant he had deposited a small bag containing the money in notes, gold, and silver, beneath the counter of the store, while he left it – unprotected – on some business. On returning he missed the money, and after making every search, he found the bag containing the greater portion of the money, “planted” underneath a house belonging to Mr Fletcher, about 200 yards from his own house. Suspicion attached to the prisoner, from the fact of he and another man being the only persons who had seen the prosecutor with the money while they were in his shop. Sergeant Morton, who arrested the prisoner, gave evidence of having found the remainder of the money also hid near the place where the other portion was found. When he arrested the prisoner where he was staying, at Fletcher’s, he did not find any money on him. He knew the prisoner by repute as a bad character. After a few remarks from Mr South as to the frail nature of the evidence of the prosecution against the prisoner, the Bench, in discharging him, expressed a doubtful opinion of his innocence.

Victoria to New Zealand Passenger Record

Jane Bulliman aged 22 years departed from Hobson’s Bay, Victoria on the ship ‘Albion’ on 2 May 1866 and arrived at Wellington. She travelled steerage and was described as English.

Evening Post 2 Nov 1877 Wellington City Council

Licenses issued for the year commencing 1st October 1877. Express License No. 89 R. Bulliman

Evening Post 15 Feb 1878 Resident Magistrate's Court

James Fenton, charged with leaving a vehicle unattended, pleaded that he had left a man in charge, and this being proved the case was dismissed. A similar charge against Richard Bulliman was adjourned until Tuesday to enable defendant to produce evidence.

Evening Post 31 May 1878 Resident Magistrate's Court – Cattle Wandering

Richard Bulliman, John Dooley, and Joseph Mair, were each fined 10s for similar offences. Tim O’Loughlin was discharged with a caution, as there were some mitigating circumstances in his case.

Evening Post 22 Oct 1878 Resident Magistrate's Court – Neglecting to carry lights

Richard Bulliman, an express-driver, was summoned for driving his express at night without carrying lights. He was fined 1s and costs.

Evening Post 14 Mar 1882 Resident Magistrate's Court – By-Law Cases

Richard Bulliman and George Bowring, for allowing animals to wander, were each fined 2s and costs, and John Webley, for a somewhat similar offence, had to pay 5s and costs.
