*Southern Cross 11 Oct 1864 Arrival of the 'Columbus' from London*

The ship Columbus, 1,277 tons, Captain Adie, arrived yesterday evening, and anchored off the North Head. She left the Downs on the 16th June, and took her final departure from Ushant on the 24th June. Experienced light N.E. trades, and crossed the line on the 27th July, in 25o 11' W longitude. The S.E. trades proved moderate, and the meridian of the Cape was made on the 23rd August. From thence strong W. and S.W. winds prevailed. She ran down her easting as far as 59o S, and passing to the south of Tasmania, sighted the North Cape on Saturday last. The barque Guadelette, hence, was spoken on the 4<sup>th</sup> instant, in longitude 163o 10' E, latitude 34o S.

The Columbus was despatched by Messrs Green, Robinson and Co. She is a fine large ship, and has good accomodation. Her commander, Captain Adie, has been presented with a testimonial by the passengers, as a token of their appreciation of his abilities as a mariner, and of the manner in which he has performed his duties. Most of the passengers appear to be in good health, and the ship is in a cleanly state. The following is a list of her passengers and cargo:-

The ship 'Columbus' arrived off the North Head last evening from London, with a full cargo of general merchandise and 185 passengers. The following is a list of their trades and occupations:- 13 farm labourers, 28 servants, 14 labourers, 2 ironmongers, 20 farmers, 1 painter, 3 blacksmiths, 1 draper, 4 carpenters, 1 wine merchant, 1 doctor, 1 cook, 1 coal miner. The 'Columbus' has arrived in harbour in good order. The

only deaths during the passage were Robert William Blankarn, aged 30, who died on the 29th July, of consumption; and Margaret Paul, aged 2 years, who died on the 27th July, of dysentery.

*New Zealand Herald 11 Oct 1864 Arrival of the ship 'Columbus' from London*

The fine ship Columbus, Captain Robert Adie, arrived off the Heads yesterday evening, after a pleasant passage of 115 days from the Downs. The following are the particulars of her passage: - Passed through the Downs on the 16th June, taking her final departure from Ushant on the 24th. Passed outside the Cape De Verd Islands, experiencing very light N.E. trades; crossed the Equator on the 27th July, in longitude 25o 11'W., and had very moderate S.E. trade winds; crossed the meridian of the Cape of Good Hope on the 23rd August, running down her easting between the parallels of 40o and 49o; in these latitudes, W. and S.W. winds were encountered with very squally, wet weather. Off Tasmania, had a hard gale from the N.E., which drove her down as far as 50o S.; after that light winds prevailed, and the North Cape was rounded at 11.30am, on Sunday last. The only ship connected with the Colonies spoken during the passage, was the barque Guadalette, five days out from this port, on the 5<sup>th</sup> inst., in longitude 163o 10' E., latitude 34o S.; wished to be reported. The Columbus brings 189 passengers, all in good health, and the ship has arrived in a clean and creditable condition. There were two deaths on the passage - one a child, and the other a young man named Robert William Blankam, aged 30 years, who died of consumption on the 29th July. There were also two births on the passage. Capt. Adie is well spoken of by the passengers, and seems to have won their highest esteem, as will be seen by the following testimonial, which we have much pleasure in giving publicity to:- "To Captain Robert Adie, Ship Columbus. Prendeville put up a splendid performance, beating standard time by 6 1-5sec. J. Bradbury, the second man, also ran excellently, and was only defeated by two yards... *Wairarapa Daily Times 19 May 1906 Athletics - New Zealand Amateur Association Meeting of Wairarapa Club*

The Wairarapa Amateur Athletic Club held a special committee meeting last evening, to meet Mr A. Davies, Hon. Secretary of the Wellington centre of the N.Z.A.A.A. The meeting was held for the purpose of discussing the question of reciprocity between the New Zealand Amateur Association and the recently formed New Zealand Athletic Union for control of cash athletics. There were present – Messrs S. A. Noble-Campbell (chair), J. Bradbury, [W. W. Chambers](#), A. E. Wilton, A. K. Johnston and G. W. Sellar. Mr Davies, in the course of his address, stated that the professional athletic societies – or, as they preferred to call themselves, the cash athletic societies – had recently formed a Union, with the object of fostering cash athletics and putting a stop to any abuses which had crept into cash athletics in the past. This Union desired the Amateur Association to reciprocate by placing cash events on the amateur programmes. For the amateurs to comply with this request Mr Davies stated would mean the altering of the whole constitution, not only of the New Zealand Amateur Athletic Association, but also of the Australasian and English Amateur Associations, to which the New Zealand body is affiliated. In other words, reciprocity in that form would simply be impossible. Mr Davies then read a motion which had recently been passed by the Wellington Centre of the N.Z.A.A.A., as follows:- “That this Centre is not prepared to entertain any proposal that would lead to the association of amateur athletics with professional sports.” It had been further decided to recommend to the New Zealand Council that the services of a representative well versed in amateur sport should be obtained to travel the colony in the interest of amateur athletics, and that the various centres be asked to contribute to same. It had been decided, if possible, to secure the Basin Reserve, for the purpose of holding a Wellington Provincial Championship meeting, on January 1<sup>st</sup>, 1907. During the discussion which followed Mr Davies’ address, the opinion was expressed that any form of reciprocity with the New Zealand Athletic Union was out of the question. Mr Wilton moved, and Mr Chambers seconded, “That this Club take no further action in regard to the placing of amateur events on the programmes of professional athletic bodies.” – Carried unanimously. On the motion of Mr Sellar, seconded by Mr Bradbury, it was decided, “That the Wairarapa Amateur Athletic Club is heartily in accord with the Wellington Centre’s proposal to send a representative to tour the colony in the interests of amateur sport.” The Otago Centre is also opposed to any arrangement being made by the N.Z.A.A.A. with the New Zealand Athletic Union. At a meeting of that Centre, recently, it was stated that the cash societies only placed amateur events on their programmes because they recognised that this form of sport was attractive to the public, and was to the advantage of the cash societies. It was stated by one member that he thought amateurs were quite strong enough to look after themselves.

*Wairarapa Daily Times 07 Jun 1906 Charge of Theft – Accused sent to Gaol*

At the Masterton S.M., Court, to-day, before Mr W. P. James, S.M., Peter Jackson was charged with the theft of ten flannel shirts, valued at £2, the property of the W.F.C.A. [William W. Chambers](#), in charge of the drapery department at the W.F.C.A., identified the shirts (produced) as having been displayed outside the W.F.C.A. premises. He missed the goods, which had not been sold to anyone, at six o’clock. Frederick Cooper, licensee of the Central Hotel, deposed to seeing accused with a bundle of flannel shirts tucked under his arm about five o’clock last evening, going along the alley way at the side of the Central Hotel. Constable Egan gave evidence to finding the goods at the rear of Messrs Hartmann, Hoar and Permain’s premises. Accused said he admitted having been drunk (with which he was also charged), but had no recollection of stealing the goods mentioned in the charge-sheet. Sergeant O’Malley stated it was the first offence of theft brought against accused. A sentence of two months’ imprisonment was passed on the charge of theft, and a fine of 5s, in default 24 hours’, was imposed on the charge of drunkenness.

The death occurred last night of Mrs Annie Dean Chambers, one of Picton's most esteemed residents. She was in her 95th year and had retained all her faculties until a fortnight ago. Born at Auckland, her parents were the late Mr and Mrs John Upham Williams. She was married in Australia and later returned to New Zealand with her husband, Mr W. W. Chambers, who died in 1925. Mr and Mrs Chambers arrived in Picton over 40 years ago, and Mr Chambers was manager of the former branch of Girlings' Ltd., at Picton. Mrs Chambers was a foundation member of the Picton Croquet Club, in which she was recognised as the Club's 'mother'. She was also one of three foundation members of the Picton Navy League. In addition to taking an active interest in the affairs of the Picton Plunket Society, of which she was patroness for many years, Mrs Chambers was a keen worker in patriotic and Red Cross activities during the First World War. She is survived by a daughter, Mrs J. A. Breayley, Wellington Street, Picton. There are seven grandchildren and nine great-grandchildren. The funeral will leave the Holy Trinity Church, Picton, for the Picton cemetery tomorrow afternoon.
