Nature of Scheme or Composition sanctioned or Order made: All property of the debtor divisible among his creditors to vest in a Trustee, and, subject to the provisions of this scheme, to be administered, as nearly as may be, according to the law of bankruptcy, and in particular Part 3 of the Act to apply. Mr Ernest Foreman, of 57, Grace-church-street, London, to be the Trustee, at such remuneration as the Committee of Inspection may fix, to give security to satisfaction of Board of Trade, and his appointment to be subject to their approval, Messrs. John Wellington Buckland, W. L. T. Foy, and F. Cooper to be the Committee of Inspection. Debtor to aid in winding up business and realizing property, and Trustee, with consent of Committee, to make such allowance to debtor as he may think fit for services rendered. All debts directed by the Act to be paid in priority to be so paid. Mr William Fletcher to repay the estate Dividends on claims of family creditors, and to withdraw own claim against estate. All costs, charges, and expenses of the proceedings in and about the filing of the petition, and consequent thereon, to be taxed and paid by the Trustee. As from the date of the confirmation of this scheme by the Court, the debtor to be discharged from all debts provable under these proceedings to same extent as if Order confirming scheme were an absolute Order of Discharge. The Receiving Order is rescinded.
