The ship 'Andrew Jackson', Captain McCullam, was to leave London for this port, with passengers and cargo, on the 10<sup>th</sup> of May last.

### Wellington Independent 24 Aug 1865 London – from our correspondent – London, June 26<sup>th</sup>, 1865

... A fine brand-new locomotive and a large quantity of railway plant, were shipped in the 'Andrew Jackson', for Auckland, at the end of last month: so that the Province of Auckland may shortly be expected to have a railway in full working order...

### Daily Southern Cross 25 Aug 1865

The fine ship 'Andrew Jackson,' Captain McCallum, arrived in harbour yesterday, from London. She brings 269 passengers, 88 of whom are nominated by friends in Auckland, and sent out by Captain Daldy; 33 have A land orders, and 33 B land orders for 40 acres; 11 have orders for 20 acres. 120 of the passengers are English, 12 Scotch, 58 Irish, and 3 are foreigners. There are 55 children. The following are the occupations:- Farmers, 32; clerks, 2; surveyor, 1; merchants, 3; storekeeper, 1; whitesmiths, 2; servants, 13; painter, 1; labourers, 6; policemen, 7; dealer, 1; sailor, 1; drysalter, 1; puddlers, 11; wives of colonists, 13.

*Evening Post 24 Dec 1910 Death and Obituary*  
On the 24<sup>th</sup> December, at his residence, Lower Hutt, George McIlvride, senior; aged 73 years.  
  
The death occurred at Lower Hutt, at 10.45 this morning of Mr George M'Ilvride, sen., a very early settler in the Valley. Deceased had been suffering from an internal disorder, for which he was operated on about five months ago. He had been ill ever since. Mr M'Ilvride was twice married, and leaves a widow and ten children – five girls and four boys by the first wife, and one girl by the second wife. Deceased was a general blacksmith, farrier, and wheelwright on the Main road, Lower Hutt. Born in Perthshire, in 1838, he came to Auckland in the ship Andrew Jackson in 1864. Settling in the Hutt, during the following year, he founded the present business, which he carried on until twelve months ago. In local politics he had served as a member of the Lower Hutt School Committee, and as a member of the Licensing Committee. For a great many years he had

been a member of the Rose of the Valley Lodge of Oddfellows, of which he was senior trustee up to the time of his death. For about thirty years he had been an elder of the Presbyterian Church. The funeral will leave his late residence on Monday, at 2.30 p.m., for the Presbyterian Cemetery, Blackbridge.
