Parish Register Entry – Ware, Hertfordshire
Nathaniel Stonard of the parish of St Olave Hart Street London batchelor and Susanna Green of the parish of Ware in the County of Hertfordshire spinster a minor were married in this Church by Licence this 3rd day of September by me W. Hughes. This marriage was solemnized between us Nath Stonard Susanna Green in the presence of us A. Green, Mary Chegers?, S. Stonard, James Green.

Tower Hamlets, Court-house, Osborne-Street, Whitechapel – Monday, Dec 10, 1792. At a numerous Meeting of the Inhabitants of the Tower Hamlets held there this day, in consequence of public advertisement. John Perry Esq., in the Chair, Resolved unanimously, that the following Declarations which was first read, be approved, and that it shall be signed by such of the inhabitants as shall approve thereof. Declaration: We whose names are hereunto subscribed, inhabitants of several parishes and districts within that division of the County of Middlesex, called the Tower Hamlets, sensible of the blessings that we and our families enjoy under the Constitution of this country, and justly alarmed at the numerous inflammatory publications and opinions that are in daily circulation, all tending to excite disaffection, and create tumults and disorders among the people, cannot better express our abhorrence of such proceedings, than by writing in one common cause to support the Constitution as established at the Revolution, 1088, and thereby give to every individual, protection to his person and property, and the uninterrupted enjoyment of those blessings which at that period were secured to English settlers. And we do pledge ourselves in our respective Parishes and Districts to suppress and discountenance all unlawful Meetings and Assemblies, whether public or private, to aid and assist the Civil Power, in bringing to justice all those who may audaciously attempt to disseminate principles inimical to the Constitution; and that we will at all times co-operate with other bodies of the people, associated for this like laudable purpose in maintaining peace and good order, enforcing a due obedience to the laws, and promoting the hapinness and prosperity of the kingdom. Resolved unanimously, That John Perry.... Nathaniel Stonard... be a Committee to attend the signing of the aforesaid Declaration, and they are hereby requested to take such measures for this purpose, and for publication in the newspapers, or otherwise, as they shall think proper...
