I have now the honour to inform you that having given his case a very full consideration I have fixed the amount of his compensation at one hundred & fifty pounds, being the amount of half a year's salary. His claim was made up of various items which though possessing considerable weight it was difficult to estimate at a pecuniary value, & I thought the best plan was to trial his case as that of a yearly service terminated without notice & award him what is I believe usually considered due in such case.

1848 No.7 F. D. Bell, Wellington to the Secretary of the New Zealand Company

Sir, I beg to enclose you a number of Dispatches from the Resident Agent at Nelson as marked in the Margin. Mr Jollie's dispatch No.3/48 refers to a matter on which the Principal Agent addressed you in his Despatch New Plymouth No.1/48 of 17 October. From the certificate of the tide waiter now transmitted by Mr Jollie, it appears that some of the contents of the box referred to were of a nature that would easily be damaged in the course of so long a voyage, without any one being to blame. I have frequently known the same thing occur & in more than one instance it has happened to myself; and there does not, therefore (seem any reason) (after the explanations now received from Nelson) for the Company interfering in the matter. In reference to the despatch No.12/48, on the subject of Mr Newdigate's land, I beg to state that in July or August 1844, acting as that gentleman's Agent, I completed the purchase of the accommodation section No.187 Waimea East, which had been partly concluded between the late Captain Wakefield, on behalf of Mr Newdigate & Mr Duppa the agent for the owner by paying Mr Duppa the balance due on the agreement: taking his receipt & engagement to execute a conveyance as soon as the Company could give the conveyance to the first owner. About two months ago I instructed my Solicitor at Nelson to prepare at once a conveyance from Mr Savage to Mr Newdigate, & I expect every day to receive and transmit it to the latter gentleman, to whom I have also written on the subject.

In June 1853 Richard Prouse, William Prouse, and William Wakeham bought an unselected Land Order No.1077 from the Trustees of Mrs Ford (Mary Molesworth) and preferred a Claim for a Grant of this Section – Claim 836, Report 677 dated 01 Aug 1853. By an agreement dated 01 Dec 1859 William Wakeham and Richard Prouse mutually agree to make an exchange. Wakeham being entitled to 50 acres of Section 11 and Prouse the other 50 although the whole section was entered as bought by R. Prouse one half of the money was advanced by Wakeham. Wakeham gives up his 50 for Prouse's third of this section. The Grant is therefore issued to William Wakeham of two thirds of the section and to William Prouse of one third. Subsequently a special agreement was entered into between the Principal Agent of the Company and Mr Johnson, allowing him to select 300 acres of Rural Land in right of the Land Order and in fulfilment of the agreement Edward Johnson on the 23<sup>rd</sup> of December 1844 selected this Section with the two following No.29 and 30. Claimed by George Moore – Claim 539 Report 655, Grant 1148 dated 07 Sep 1857 signed by T. Gore Browne. Delivered to George Moore 25 Mar 1858.

A Second Series Special Land Order No.112 was issued to David Roberts 19 Nov 1840 who transferred to Edward Johnson 04 Jun 1841. J. Claimed by George Moore – Claim 539, Report 655, Grant 1148 dated 07 Sep 1857 signed T. Gore Browne and delivered to George Moore 25 Mar 1858.

This section was originally selected as a Native Reserve. Subsequently sold by the Natives to William Fitzherbert under the provisions of "The Native Reserves Amendment Act 1862." Crown Grant issued to William Fitzherbert under Crown Grants Act No.2 1862. Grant 2287d dated 06 May 1864.

This section was selected by A. W. Shand 04 Jan 1843 in right of Land Order No.1060 issued to Frank Johnson 01 Aug 1839 who transferred to Archibald Watson Shand 22 May 1840 who transferred to Rev A. Shand 04 May 1842 who retransferred to Archibald Watson Shand 11 Jun 1850. Conveyed by Archibald Watson Shand 06 Oct 1851 to David Dick. Claimed by David Dick 15 Dec 1851 – Claim 258, Report 191, Grant 2948 dated 10 Jul 1869 signed G. F. Bowen. Delivered to David Dick 06 Dec 1869. The Grant antevested as from 06 Oct 1851.

This section was selected 03 Jan 1843 by James Jackson in right of Land Order No.931 issued to Henry Shafto Harrison who transferred to James Jackson 30 Sep 1843. James Jackson deceased. Probate of Will 03 Sep 1846 appointing Emma his wife, J. D. Greenwood and I. E. Featherston executors – bequeathing Section 3 Lowry Bay to his wife Emma during her natural life and after her death to his sister Eliza Wood during her life independently of her husband and after her death to the Children of his sister Eliza "as tenants in common and not as joint tenants." Authority to his wife Emma to Grant Leases of the property (on which she has only a life interest) for 21 years. Grant claimed by Emma Jackson 29 Dec 1851 – Claim 329, Report 268, Grant issued to Emma Jackson No.120 Draft No.517 dated 28 Feb 1853 signed George Grey. Haberdum – "To hold unto the said Emma Jackson during the term of her natural life." Grant delivered to William Lyon attorney of Emma Jackson 25 Oct 1859.

Taylor sold 25 acres to Hugh Sinclair but no conveyance was issued and he afterwards sold the remainder of the section to Robert Neill and on 16 Oct 1856 Taylor & Sinclair join in a conveyance to Neill of the whole section. Claimed by Robert Neill – Claim 1361, Report 1213, Grant 1983 dated 12 Aug 1861 signed T. Gore Browne delivered to Robert Neill 19 May 1864.

Purchased under the Land Regulations by William Fitzherbert 26 Jan 1854. Application 309a. Grant 3069 delivered to W. Fitzherbert 05 Jan 1870.

#### Pahautanui No.1

This Section was selected by J. W. Child 07 Apr 1842 for John Abbott in right of Preliminary Land order 679 issued to George Stansfield. See Register of Transfer No.267. Claimed by C. von Alzdorf for John Abbott – Claim 963 Report 857. Subsequently a Small Farm Agricultural Reserve was laid out at Pakuratahi which was intended to include this section. Mr Commissioner Fox issued a Certificate entitling Mr Abbott to select 100 acres elsewhere. This Certificate was sold to J. H. and R. D. Wallace who exercised the same in the selection of Land under the Government Regulations in the Wairarapa district.

See Register of Application No.1440; See subsequent amended Application No.1758; See Schedule of the amount of land awarded by Mr Commissioner Fox in exchange for this section No.57/89. Mr Clifford's terms of acceptance attached; See also Auction sale selection Plan dated 11 Feb 1858 signed David Lewis. According to which it does not appear that this section is included in the "Pahautanui Agricultural Reserve." Consequently it now remains Crown Land (01 Sep 1874). Purchased at Auction by William Galloway on 23 Apr 1878 – see Register of Application No.5499. Grant 62... 112 acres 11 perches.

This Section was selected by J. W. Child 07 Apr 1842 for Henry Wilkinson Farrar in right of Preliminary Land Order 643 issued to Harry Hughlings. See Register of Transfer No.80. Claimed by C. von Alzdorf for H. W. Farrar – Claim 974, Report 773. The same remarks apply to the subsequent dealings with this section as to No.1 in this district, so far as relates to an exchange for land elsewhere. See schedule and Auction Plan referred to in remarks on Section 1. Crown Land 01 Sep 1874. Purchased at Auction by Charles Carter and William Alfred Carter 23 Apr 1878. See Register of Applications No.5499. Grant 6247 for 91 acres 2 roods 8 perches.

---

#### Pahautanui Nos 3, 4 and 5

These three sections were originally selected as Native Reserves by Edmund Halswell under orders of choice 645, 622 and 590. Subsequently they were thrown up by Colonel McCleverty the Commissioner for settling Native Claims, in exchange for Sections in the Porirua Bay which had been selected under Land orders issued to purchasers from the Company. Thrown open for selection by the Company's Principal Agent 01 Aug 1848. They remained unselected until 1851 when Frances Bradey applied for them in exchange for two "Resident Landholders Scrip" Nos 75 & 76 for 150 acres each. Claimed by Francis Bradey 29 Dec 1851 – Claim 4... Report 324, Grant 6104 dated 05 Jul 1880 and delivered to...

---

#### Pahautanui No.6

This Section was originally selected as a Native Reserve – see Remarks on previous sections 3, 4, 5. Taken by Henry St. Hill agent for Sir Michael Seymour 01 Aug 1848 in right of an unselected Land order issued to Michael Seymour Captain R.N. Claimed by Sir M. Seymour – Claim 1470, report 1492. Sir M. Seymour had also two Supplementary Land orders for 75 acres each which was selected out of unsurveyed land adjoining the surveyed part of Pahautanui. 150 acres the section numbered 22. See Minutes to Report 1492. Grant 6103 for 116 acres 37 perches delivered to C. B. Izard 19 Jul 1880.

#### Pahautanui No.7

This Section was selected 07 Apr 1842 by Henry St. Hill for George Frederick Young the original owner of Preliminary Land order 283. 25 acres claimed by David Johnston – Claim 213, Report 243. David Johnston subsequently sold his right to the 25 acres to Thomas Hollis Stace who preferred a claim for a Grant of the same. Thomas Hollis Stance – Claim 998, Report 992, Grant 1113 issued to T. H. Stace dated 10 Dec 1856 (signed Thomas Gore Browne) and delivered to Robert Hart, Solicitor 04 Apr 1857. The remainder of the section 75 acres more or less claimed by the Executors and Trustees of the Estate of Robert Jillett deceased – Claim 1515, Report 1390, Grant 4136.

#### Pahautanui No.8

This Section was selected 08 Apr 1842 by Captain Smith for Messrs James Boddington and William Ive the original owners of Preliminary Land order 1014. James Boddington & William Ive transferred to Alexander Currie 06 Sep 1839 Number of Registry of transfer 45. Claimed for Alexander Currie by his Attorney Francis Dillon Bell 06 Oct 1868 – Claim 1701, Report 1563, Grant 5372. A Supplementary Land order issued to Alexander Currie who assigned the same 30 Aug 1851 to William Bowler on behalf of A. Bowler a Minor who claimed Government Scrip in exchange – Claim 859, Report 718. Government Scrip No.241 for £75 delivered to William Bowler 30 Aug 1853. Number Receipt 54.

---

#### Pahautanui No.9

This Section was selected 07 Apr 1842 by J. W. Child for Thomas Varley the original owner of Preliminary Land Order 604. Claimed by Thomas Varley – Claim 956, Report 858. Subsequently a “Small Farm Block” called “Pahautanui Agricultural Reserve” was laid off in this district which included this section, and in order to carry out the scheme Mr Commissioner Fox issued a Certificate entitling the owner Mr Varley to select 125 acres elsewhere in exchange. The Certificate was subsequently sold to J. H. and R. D. Wallace who exercised the same in the selection of land under the Government Regulations in the Wairarapa district. See Register Application 1451. See Schedule of Mr Commissioner Fox’s Award for this Section No.57/89. Mr Clifford’s terms of acceptance attached.

#### Pahautanui No.10

This Section was selected by Captain Smith 07 Apr 1842 for William Adye the original owner of Preliminary Land Order 606. Claimed for William Adye by his Attorney William Waring Taylor 07 Feb 1859 – Claim 1391, Report 1272. Grant issued to W. Adye No.2186 dated 05 Dec 1862 (signed G. Grey) delivered to W. W. Taylor 20 Sep 1864.

A Supplementary Land order was issued in favour of William Adye but subsequently lost in a flood which occurred at Boambolo in the district of Yass, New South Wales. Relief was sought under the provisions of “The Lost Land Order Act 1861” under which he is reported entitled to select 75 acres in the Province of Wellington. The selection was made by Mr Taylor in the Rangitiki district adjoining Blocks XLVI and XLVII. See Reports 1363 New Zealand Land Claims Ordinance and Report 3 Lost Land Order Act 1861 both dated 01 Mar 1865.

---

#### Pahautanui No.11

Was originally selected under Land Order 1035 issued to John Gemmil of Paisley, who transferred to Robert Glasgow, who threw up the section for land at Turakina. See Minutes of Report 347. The section is included in the “Agricultural Reserve.”

---

#### Pahautanui No.12

This Section was selected by Captain Smith 07 Apr 1842 for George Robins the original owner of Preliminary Land Order 573. There is no record of transfer from George Robins, nor has any Supplementary Land order been issued, nor any Claim preferred for either the Town or Country land, when the following documents were deposited.

Mr Clifford deposited 22 May 1860 part 1 of this Land order 573 with two others 932 & 1029 issued to George Robins together with a deed of conveyance dated 27 Nov 1858 from Edmund Robins to Thomas Parkinson conveying the three Land orders with the Town and Country selections under them. This deed recites that George Robins died on 08 Feb 1847 and by his Will bearing date 09 Mar 1844 gave, devised and bequeathed all his freehold and copyhold estates whatsoever and wheresoever (except such as were vested in him upon trust) to John Squire, James Parke and Edmund Robins, in trust with Power to dispose of the same. That John Squire died 16 Aug 1852 and that James Parke died 23 Feb 1854 leaving the said Edmund Robins (Testators Cousin) sole surviving trustee. See Memo of Commissioner to Mr Thomas Hunt of Taranaki Letter Book 67/... 16 Mar 1867 Page 272. The Deed will be found in Packet P unreported papers.

The Directors of the Halifax Joint Stock Bank Company preferred a Claim for the Section 02 Feb 1876 by their Attorney T. Hirst – Claim 1738, Report 1594, Grant 5232.

---

#### Pahautanui Nos 13, 14, 15, 16, 17, 18, 19

Included in the Agricultural Reserve. 13, 15, 17, 19 were unselected sections. 14, 16, 18 were sections thrown up by Mr Tollemache.

---

---

Pahautanui No.20

This Section was selected by Captain Smith 08 Apr 1842 for Benjamin Charles Thomas Gray the original owner of Land Order 812. A Supplementary Land order was issued to B. C. T. Gray for this Land order which was exchanged for Government Scrip and delivered to C. von Alzdorf 08 Feb 1854. A Claim for a Grant of the section to Gray was preferred by Alzdorf 05 Nov 1853 – Claim 950, Reported entitled No.876.

Note: The greater part of the sections laid off in this district were selected by the agent of Hon. A. G. Tollemache but subsequently thrown up by him for Government Scrip. The Provincial Government in 1858 determined to lay off a Block in small allotments for an Agricultural Reserve. There were however a few other selections besides those thrown up by Mr Tollemache which had to be arranged for before the scheme could be carried out. Mr Clifford was Agent for several of them and he accepted on their behalf Compensation Certificates for Land to be selected elsewhere, and those Absentees for whom there were no Agents (there being only four) it was arranged to leave their sections as laid down on the original plan.

Through some inadvertence of Mr Park the Principal Surveyor in plotting the Block he cut up this section and included it in the small allotment agricultural reserve. See Commissioner Letter to Mr W. France in reply to an enquiry in the matter 23 Aug 1860 – 60/293. Grant 1366 – 40/4 acres

---

Pahautanui Nos (21-22), 23, 24, 25, 26, 27, 28, 29, 30, 31

Included in the Agricultural Reserve. Nos 21, 22, 30, 31 were unselected sections. Nos 23, 24, 25, 26, 27, 28, 29 were sections thrown up by Mr Tollemache. There are two fresh sections number 21 & 22 outside the Reserve in the Pahautanui district near the sections numbered 33 & 34 which has been selected by Mr St. Hill. Section 21 containing 210 acres on behalf of John Henry Luscombe – see Minutes Report 1533. The other section, No.22 containing 150 acres, on behalf of Michael Seymour – see Minutes Report 1492. The legal Estate to be interested in these two sections (21 & 22) as from 08 Apr 1844.

This Section was selected by Charles E. von Alzdorf 08 Apr 1842 for William Henry Rawson the original owner of Preliminary Land Order 955. Supplementary Land order issued to W. H. Rawson. Claim preferred on behalf of W. H. Rawson – Claim 944, Reported entitled No.850. Subsequently a “Small Farm Agricultural Reserve” was proposed to be carried out in the Pahautanui district which included this Section. Mr Clifford at the time, being Mr Rawson’s Agent, agreed with Mr Commissioner Fox (in order to enable the Government to carry out the scheme) to take a Certificate entitling Mr Rawson to select 150 acres elsewhere. This Certificate was subsequently sold to J. H. and R. D. Wallace who exercised the same in the selection of land under the Government Regulations in the Wairarapa district. See Register of Applications No.1440. See subsequent amended application No.1758. See Schedule of Mr Commissioner Fox’s Award for this Section 57/89. Mr Clifford’s terms of acceptance attached.

---

#### Pahautanui No.33

This Section was selected by J. W. Child 07 Apr 1842 for Henry Suter the original owner of Preliminary Land Order 954. There is no record of a transfer from Henry Suter nor has any Supplementary Land order been issued. A verbal Notice was given by Mr Alzdorf 27 May 1854 that Henry Suter had conveyed all his right and interest in the Land order to Robert Wainhouse. Robert Wainhouse died 03 Mar 1856 and Probate Copy of the Will has been exhibited. The Executors named therein are William Wainhouse, John Emmet and John Edward Wainhouse. Mr Clifford being agent and holding a Power of Attorney from the Executors, accepted, for this section also for the reasons stated in the remarks upon the previous section, a Certificate entitling the Executors to select 150 acres of Rural land elsewhere. The Certificate sold to, and executed by J. H. and R. D. Wallace under the Government Regulations in the Wairarapa district. See Register of Applications No.1440. See Subsequent amended application No.1758.

In 1864 John Edward Wainhouse the only surviving Executor of the aforesaid Robert Wainhouse deceased and in preferring a Claim for a Grant of the Town Land selected under the above named Land order deposited the Conveyance referred to from Henry Suter to Robert Wainhouse dated 05 Oct 1853. See Schedule of Mr Commissioner Fox’s Award for this section – 57/89. Mr Clifford’s terms of acceptance attached.

#### Pahautanui No.63
